

ORDINANCE NUMBER 17-06-028

**AN ORDINANCE OF THE BLUE ISLAND PARK DISTRICT
ASCERTAINING THE PREVAILING RATE OF WAGES FOR
LABORERS, WORKMEN AND MECHANICS EMPLOYED ON
PUBLIC WORKS OF THE BLUE ISLAND PARK DISTRICT**

WHEREAS, the State of Illinois has enacted “An ACT regulating wages of laborers, mechanics and other workers employed in any public works by the State, County, City or any public body or any political subdivision or by anyone under contract for public works”, approved June 26, 1941, as amended, being Chapter 820 ILCS 130/1-12, Illinois Compiled Statutes; and

WHEREAS, the aforesaid Act requires that the **BLUE ISLAND PARK DISTRICT** investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of the Blue Island Park District employed in performing construction of public works, for the **Blue Island Park District**.

NOW, THEREFORE, BE IT ORDAINED by the President of the Board of Commissioners of the **Blue Island Park District**, Cook County, Illinois, as follows:

SECTION 1

To the extent and as required by “An Act regulating wages of laborers, mechanics and other workers employed in any public works by the State, County, City or any public body or any political subdivision or by anyone under contract for public works” approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in the construction of public works coming under the jurisdiction of the **Blue Island Park District** is hereby ascertained to be the same as the prevailing rate of wages for construction work in the **Cook County** area as determined by the Department of Labor of the State of Illinois as of **June 2017**, a copy of that determination being attached hereto as Exhibit “A” and incorporated herein by reference. The definition of any terms appearing in this Ordinance which are also used in the aforesaid Act shall be the same as in said Act.

SECTION 2

Nothing herein shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works of the **Blue Island Park District** to the extent required by the aforesaid Act.

SECTION 3

The **President of the Board of Commissioners** shall publicly post or keep available for inspection by any interested party in the main office of the **Blue Island Park District** this determination of such prevailing rate of wage.

SECTION 4

The **President of the Board of Commissioners** shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed, or file their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

SECTION 5

The **Blue Island Park District** shall promptly file a certified copy of this Ordinance with both the Secretary of State Index Division and the Department of Labor of the State of Illinois.

SECTION 6

The **President of the Board of Commissioners** shall cause a notice to be published in a newspaper of general circulation within the area that the determination of prevailing wages has been made. Said notice shall conform substantially to the notice attached hereto. Such publication shall constitute notice that this is the determination of the **Blue Island Park District** and is effective.

NOTICE OF BLUE ISLAND PARK DISTRICT ORDINANCE NO. 10-05-026 RELATING TO PREVAILING WAGE RATES

TAKE NOTICE that the Board of Commissioners of the Blue Island Park District of Blue Island, Illinois, pursuant to “An Act regulating wages of laborers, mechanics and other workers employed in any public works by the State, county, city or any public body or any political subdivision or by anyone under contract for public works”, approved January 26, 1941, as amended, and codified as 820 ILCS 130/0.01, *et seq.*, has determined on, and as effective from June 24, 2017, that the general prevailing rate of wages in this locality for laborers, mechanics, and other workers engaged in the construction of public works coming under the jurisdiction of the Blue Island Park District is the same as determined by the Department of Labor of the State of Illinois for Cook County as of June 24, 2017.
