#### 2. **DISCUSSION** – Festival Committee Review.

- a. Prior to tonights meeting, Commissioner Powers and park staff met to discuss new direction for the upcoming festivals. Starting with the Dragon Boat, a more family friendly activities need to be added. Possible kids tent or activities could be added. Possibility of crafts or vendors on the walking bridge might hold the audience more. Another idea would be an animal show, face painter and other activities in the area. Sponsors would be needed to help offset the cost of the events. Pricing will still be \$500 for teams, and advertising needs to start as soon as possible. Budget to be reviewed.
- b. BBQ on the Hill may also be turned into a Blue Grass music or Blues and BBQ with BBQ venders. Target dates are September 23 to 25, 2022. Holding a competitor's event will need to be reconsidered or have them bring their own products to cook instead of Park District providing to lower cost. Festival committee will be organized to review options for Dragon Boat and BBQ on the Hill.
- c. Expansion of Trunk or Treat to turn it into more of a fall festival and to possibly add an event for the skate park.

#### 3. DIRECTORS REPORT:

- a. There was an accident with the F250, it was near the end of its life span. Options are to buy a new truck or investigate used trucks. Commissioner Power stated that there are too many used trucks that are not worth looking into that option. Park not in the financial position to purchase a new truck currently. Financing is possible option.
- b. Luiz Montoya reached out to District 130 and they have agreed to let the park use their gym for our free soccer conditioning program to get the kids active prior to the summer program.
- c. Free monthly craft class have started, first one was sold out and the next one will be St. Patty's day free craft class on March 10, 2022.
- d. Director Ruthenberg spoke to the city regarding the little league fields. Joint care of the two parks between the city and park district or the park district taking over the insurance and care of the two fields. More discussion to follow.
- e. Joshua Edwards has finalized dates and times for the free baseball clinic at the Rec Center that will start in the month of March.
- f. Commissioner Powers had contact with a vendor that is looking to take over all concessions for the park district for a fee. He will look into this option for more information.
