- 3. DISCUSSION Summer Camp Update. First session had 139 enrolled with 96 resident and 43 non-resident, second session 196 with 122 resident, 72 non-resident, third session 137 resident 86 non-resident 51. Recreation Center is being used on days of inclement weather. Commissioner Sinde spoke with Joshua Edwards about surveys to parents and children.
- **4. DISCUSSION** Pool Update. Pool passes sales are currently at \$35,000 in pool passes and \$4,000 in swim lessons, daily entrance fees currently \$25,000 as of July. Pool is in process of hiring additional guards. Commissioner Sinde said spoke to Bob Waters regarding replacing the boiler. Pool attendance not impacted. Splash pad may stay open for hot days. Vending machines are getting some negative review online. Looking at possible credit card machines for concessions.

- e. Master Plan. 2 companies have been contacted. Commissioners want both companies to attend meeting and present proposals to the board.
