Public Comments: Diane Cantelo of 5240 W. Laramie Crestwood. Property owner and taxpayer in Blue Island. I am always asked how are school and parks I have children that live and teach in Blue Island. Parks are important, late-night calls at 12 at night that a kid is in the emergency room because beaten up by gang members because they didn't want to join the gang. Who do they call? They call these people (camp staff) These people sit and hold hands of the child and parents. You are not going to find this in many people. Then there are the kids that could go the right way or the wrong way. After working camp all day, where do they go? They go to that kid's house day after day after day to try to give an intervention. Then you have the kids that are limping, because their shoes two sizes two small because the mother put the little brother's shoes on them. What do they do? They go out and buy the kid shoes, or they buy the kids clothes. That's not on the clock, that's not on a time sheet, that's what they do. So, it's more than just a day camp. It's about the kids, and everyone sitting here on this park board, it should be about the kids. With all the times they spend with these kids, they have to pay rent, they have to pay bills and for gas. I just felt it was important that I came here to say that. And the way that the economics are, I just want you to consider what their request is.

Reviewed other park districts and overview of pricing and attendance. In 2021, three sessions totals; first session 150 participants, second session over 200, third session over 200. Rates for that year was \$275 resident, \$390 non-resident with \$15 activity fee. Reviewed camp from other park districts and compared pricing. Suggestion is to raise our prices up to \$25 a day per resident and \$30 a day for non-resident. This would place us in the middle of pricing with the other camps.
