3. Directors Report:

a. Director Ruthenberg addressed the board regarding the incident over the September 23rd weekend. Chief of Police Farr addressed the board and informed them of the fatal shooting at the Memorial Park during the Untouchables football game. The Park District currently has no cameras within the area of the Memorial field. There are some leads as to the car used, it was found to be stolen with stolen plates. Some ring cameras from nearby houses and a redlight camera were helpful in identifying the vehicle used. The Police Department have updated their camera system and is recommending that the park district also use the same company, which will feed into the police department system. Director Ruthenberg was praised for the quick response and it was noted that first responders arrived within two minutes of the call.

Directors Report Continued:

Thomas Wogan, Administrator for the city of Blue Island and former park district director stated that a review of rental policies and possible police patrol during large groups. Park District security is scheduled for all events, but a police car presence may help to defuse any future incidents. Director Ruthenberg stated that the following weekend, the city will provide an officer for the soccer games. There could be Possible 400 at one time with rentals plus the pool attendees. Director Ruthenberg will address other park directors at the next SWSRA meeting regarding policies. Question was asked if cameras would be at Memorial Park only and if there are any Grants available to help with the cost? To start with, Memorial will be the first park to install cameras, and added over the next few years. The 2024 budget will have funds available for camera upgrades.

- c. Playgrounds will have new mulch. Insurance states it must be done.
- d. Pest control company to be transferred from Orkin to a local company. Barton pest control,
